Since the Visa Code came into force, transit visa (B) is now covered by the Schengen general visa (C). Originally, the B visa allowed one to cross the Schengen area by land in a maximum of 5 days. Category C: Short-Term Visa The Schengen visa (C) allows a short stay in the Schengen area for a maximum of 90 days within a 6-month period.
